STUD SERVICE AGREEMENT

This agreement is made between the Stud Owner (aka North Country Kennels) and the Bitch Owner:

Payment Due The Stud Owner

Stud Fee \$ _____, First Pick Of The Litter, Second Pick

If the parties agree on a stud fee, the Bitch Owner must pay the stud fee at the time of first breeding. If the payment option is first or second choice of the litter, Stud Owner will make a choice no later than eight (8) weeks of age. Stud fee is non-refundable.

Stud Owner's Representations

- STUD HEALTH GUARANTEE:** Stud Owner guarantees that the stud is healthy, potent, is current on all immunizations, de-worming and free of signs and symptoms of disease or congenital defects.
- CONCEPTION FAILURE:** If the bitch fails to conceive, Stud Owner will provide a second stud service at no charge for the bitch, provided the Bitch Owner notifies within 7 days after the projected whelping date. There is no third breeding.
- GOOD CARE OF BITCH:** Stud Owner will provide good care of the bitch while at the facility. The bitch will receive the same care as all other dogs.
- TWO BREEDINGS:** A stud service will consist of two natural ties. The Stud Owner will decide on which procedure to use based on the temperaments and abilities of the stud and bitch at the time of the service.
- LITTER REGISTRATION:** Stud Owner will only sign the litter registration application after all fees and conditions of this agreement are met by Bitch Owner.

Bitch Owner's Representations

- 5. **BITCH HEALTH GUARANTEE:** Bitch Owner guarantees the bitch is current on all immunizations, de-worming and free from any diseases and congenital defects.
- 6. **BREEDING DATE:** It's the responsibility of the Bitch Owner to determine the optimum time for breeding, (the recommended time is between day 10 -14 of their cycle) set an appointment for stud service and get the bitch to the Stud Owner.
- 7. **PUPPY OWNERS:** Bitch Owner will not knowingly sell, give or release any puppy from this breeding to a puppy mill, animal testing facility, research facility or any agent for these.
- 8. **GENETIC DEFECTS IN LITTER:** Bitch Owner will disclose to Stud Owner of any genetic defects that appear in any puppy from this breeding.
- 9. **PURITY OF LITTER:** Bitch Owner will not expose the bitch to any other stud dog or other intact male dogs before or after the breeding until the bitch has completed her heat cycle.
- 10. **RESPONSIBILITY OF COSTS:** Bitch owner is responsible for all transportation costs of the bitch to and from the Stud Owner's premises. In addition, Bitch Owner is responsible for the cost of veterinary care (if any) for the bitch while she is under the Stud Owner's supervision.
- 11. **PAYMENT:** Payment is due in full at the time of the first breeding. Payment must be in the form of cash, personal check, cashier's check or money order. Stud service will not be provided unless the check has cleared. There will be an additional \$25.00 fee for insufficient funds.
- 12. **INDEMNITY:** Bitch Owner agrees that if his or her actions or failure to act result in any claim, suit, loss, damage, injury, death, or liability, Bitch Owner will defend, indemnify and hold Stud Owner harmless and will pay all of Stud Owner's cost and expenses including reasonable attorney fees, any amount paid in settlement and any award or judgment.
- 13. **RELEASE OF CLAIMS:** The Bitch Owner hereby releases from responsibility Stud Owner from any liabilities and/or damage to the bitch while she is in the care of the Stud Owner in as much as the Stud Owner makes every reasonable effort to prevent damage to the bitch while she is in the care of the Stud Owner.
- 14. **LIMITATION OF ACTIONS:** Any action or claim brought by Bitch Owner against Stud Owner for breach of this Contract or for loss due to negligence must be brought within one (1) year of the date such claim or loss occurs.
- 15. **JURISDICTION:** Bitch Owner agrees that he or she understands this contract fully and that this contract is in the jurisdiction of the Province of Saskatchewan, in the RM of Shellbrook in which the Stud Owner resides and does business.

Mediation And Arbitration

Mediation and arbitration lower any potential legal costs for both the Stud Owner and the Bitch Owner.

If a dispute arises under this contract, the Stud Owner and the Bitch Owner agree to first try to resolve it with the help of a mutually agreed-upon mediator in the jurisdiction of this contract. Any costs and fees other than attorney fees associated with the mediation will be shared equally by both the Stud Owner and the Bitch Owner.

If it proves impossible to arrive at a mutually satisfactory solution through mediation, the Stud Owner and the Bitch Owner agree to submit the dispute to a binding arbitration proceeding located closest to the residence or business location of the Stud Owner, under the rules of the Canadian Arbitration Association. Judgment upon the award rendered by the arbitration may be entered in any court with jurisdiction to do so.

Entire Agreement

This contract represents the entire agreement between the parties. The Stud Owner and the Bitch Owner have made no other agreements, promises, or representations, verbal or implied, unless specifically stated in this written agreement.
